Our semi-automated EDD processing system has been affected by a Windows 2010 system update that has disabled the network functions associated with reading to and writing from our outdated VB6 EDSA program. While the newer parts of the system are unaffected, the crucial aspects of creating catalog numbers and actually processing EDDs that are currently in the queue have been affected beginning with EDDs submitted late on July 8th and all those going forward. We are in the process of completing a dot-net version of the EDSA program to replace the older version, after which all backlogged EDDs will be run through the new system and approval or rejection letters sent out to their respective submitters. It is difficult to determine a timeframe in which this transition will be completed, so in the meantime, we will be evaluating EDDs one-by-one only for cases with impending close-outs that are dependent upon the submission of the approval notification. These will be unofficial approvals until the system is back on-line, at which time official approval or rejection notices will be forthcoming.

One EDD in our system matches your description, It has the Key IDs Deliverable = EDD_100919; Submission = SUB_533523. It was manually checked on July 20, 2021 and was found to be approvable by the external version of EDSA. It is anticipated that the EDD will pass the dotNet version of EDSA when it is fully implemented. Until that time, there will be no catalog (HB) number associated with this EDD and you will have to use the submission number (SUB_533523) as the unique identifier should questions arise. Upon acceptance of the dotNet version of EDSA, your final approval letter will be sent as usual via email. Should you have further concerns, do not hesitate to contact us.
