This appendix includes manifests for hazardous wastes which were removed during the excavation of the Forrest Street as part of the soil remediation activities being conducted for the Garfield Avenue Group Sites. This appendix also includes manifests for wastes removed during full-scale remedial activities, wastes generated during groundwater treatment system operations, and wastes not directly loaded during excavation activities (i.e., well installation and remedial investigation-related activities that occurred concurrently with remediation during this time frame).

Forrest Street was excavated concurrently with portions of Forrest Street Properties (FSP). During this phase of work, waste manifests and bills of lading were tracked by sets of one to four grids. Loads that were from grids or sets of grids located only on FSP are not included here. Loads that were removed from grids or sets of grids that straddle the Forrest Street and FSP boundary are included in both Remedial Action Reports.
